In summer 2013, I participated in the EU Top-up Summer Programme to visit various European Union institutions and attend lectures as held by the officials from different EU departments in Brussels in Belgium for 5 days. The MP who represents United Kingdom states that the ultimate goal is to transform EU from a union to a federal state, such as USA and Australia, which EU would have bigger power to enforce its laws and policies which encourages its member states to unite

and work together as one to increase its economic and political influence in the world. On the other hand, we had the opportunity to visit the HKETO, College of Europe, and Brugge. These activities have given me an insight of the role of the government of HKSAR has internationally and introduced me to the elite institution where a lot of famous and influential diplomats graduated.
